Description: If the definition of insanity is doing the same thing and expecting different results, why do many of us fall back on the same (ineffective) messages when we talk about the work of the state courts? With updated polling results and fresh insights from focus groups, the National Center for State Courts (NCSC) is building a new approach to talk about the state courts in a way that will enhance public trust and confidence. Then learn, from a PIO's perspective, how a local court took a holistic view of engagement to improve not only the perception of the court but its actual function. Effectively Using Court Spaces to Engage the Public (1.5 MCLE)

Well-known for embracing emerging technologies to modernize courts and their delivery of justice, Judge Schlegel will help push us outside our comfort zones to consider creative ways generative artificial intelligence might help us position our courts to better serve the public.

Drawing on her background in complex litigation, Professor Henson will help us identify the questions we should be asking ourselves to help build appropriate guardrails around the use of artificial intelligence in court communications.
